Virginia Tax Credits for Your Donations to Campagna Center

What is the NAPE tax credit program? How is Campagna involved?

The Neighborhood Assistance Act Tax Credit Program for Education (NAPE) allows individuals or businesses to receive tax credits from the Commonwealth of Virginia for qualifying donations made to approved “neighborhood organizations.” The value of each credit is up to 65% on the dollar: e.g., a donation of \$1000 can be rewarded with \$650 in Virginia state tax credits. The program is administered by the Virginia Department of Education (VDOE) and credits are awarded for the tax year within which the qualifying donation is made.

Campagna is an approved “neighborhood organization” and was awarded \$442,274.88 in tax credits to award to donors during the NAPE program year of July 1, 2026-June 30, 2027. This means that up to \$680,422.89 worth of qualifying donations made to Campagna between July 2026 and June 2027 can be rewarded with tax credits on a first-come, first-serve basis. And while neighborhood organizations may give out credits that are worth less than 65% of a donation’s value, Campagna gives the full 65%.

As an example, if you make a \$1,000 unrestricted donation, you can receive \$650 in Virginia tax credits. For a \$2,000 donation, you can receive \$1,300 in credits, and so on.

\$1,371.50

As an example, if you sponsor an event at the \$2,500 level, you can receive \$1,371.50 in Virginia tax credits (\$2,110 of your sponsorship is tax deductible and thus eligible for credits). For a \$5,000 sponsorship, you can receive \$2,912 in credits, and so on.

Campagna awards tax credits on a first-come, first-serve basis.

What is a qualifying donation?

Campagna defines a qualifying donation as:

- An unrestricted donation of \$1000 or more
- NEW: An event sponsorship of \$2500 or more
- The following donation types qualify:
 - Checks
 - Credit Card Payments
 - Stock/Marketable Securities
 - Cash
 - ACH/Wire Payments

What donations are not eligible?

- Gifts from Donor Advised Funds (DAF)
- Qualified Charitable Distributions (QCD)
- In-kind donations
- Donations under \$1000/event sponsorships under \$2500
- Donations to the capital campaign

How can I receive NAPE credits from Campagna for myself or my business?

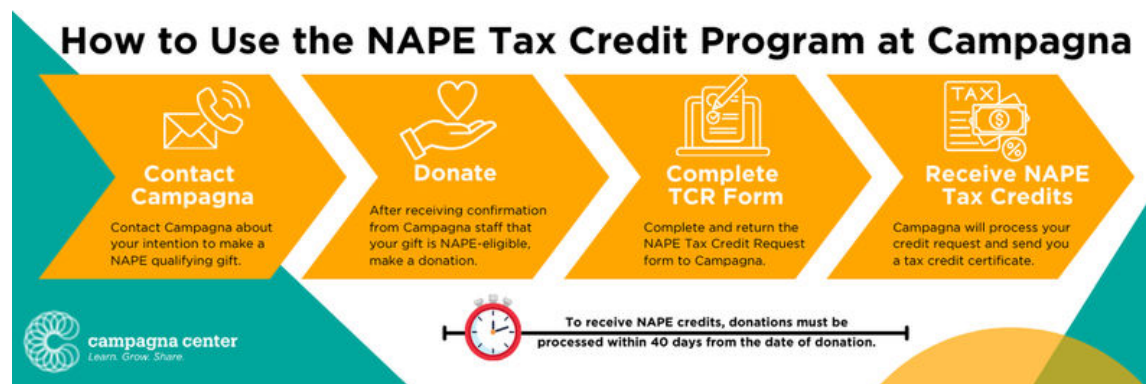
Before making a donation for which you would like to receive NAPE credits, please contact Campagna Center at developmentoffice@campagnacenter.org to confirm we still have credits available.

Once you've received confirmation from Campagna that there are credits available, you may proceed to make a qualifying donation (see donations that are not eligible, above). Once you make a donation, we have 40 days to process your NAPE credits before your donation becomes ineligible to receive credits. Please promptly fill out the NAPE Contribution Notification Form—there are separate versions for individuals (TCR-I) and businesses (TCR-B)—and please return it to Campagna via email or mail, or by bringing it to our office. Please ensure you have completed Section 1 and signed and dated the form in Section 3. Campagna staff can assist with filling out this form if you have any questions.

Once Campagna staff have the form, they will process your donation with the Virginia Department of Education. Once this process is complete, they will email you a certificate for your NAPE tax credits for use when filing your Virginia taxes.

Process and Timeline

1. Contact Campagna with intention to make a NAPE-qualifying gift
2. Receive approval from Campagna staff
3. Make donation (40-day timer starts)
4. Fill out NAPE form (if we have an email address on file for you, we will send this to you once you have made a donation)



5. Return NAPE form to Campagna staff
6. Campagna staff process donation with the VDOE
7. NAPE credit certificate is awarded by VDOE (40-day count ends)
8. Campagna staff email you a copy of your NAPE credit certificate
9. File your taxes for the year when you made the gift and receive your tax credits
